Tara Dressler, director for trademarks in the Office of University Counsel, recently was honored as the 2022 President's Employee of the Year.

Four newly elected members of Board of Regents to be sworn in today[4]

The four newly elected members of the University of Colorado Board of Regents will take their oaths of office today, Jan. 5, 2023.

The ceremony is set for 4 p.m. at CU Denver in the atrium of the Student Commons Building, 1201 Larimer St.

The board members who will be sworn in by Colorado Supreme Court Chief Justice Brian D. Boatright are: **Wanda L. James**, 1st Congressional District **Frank McNulty**, 4th Congressional District **Kenneth Michael Montera**, 5th Congressional District **Mark VanDriel**, 8th Congressional District

All four were elected to the board for the first time during the November 2022 general election. Montera, vice chair, was appointed by Gov. Jared Polis to fill a vacancy in late 2021 and has served on the board since then.

Thursday's event also includes scheduled appearances by Regents Lesley Smith (chair), Callie Rennison, Ilana Spiegel, Sue Sharkey, Nolbert Chavez and Glen Gallegos, as well as CU President Todd Saliman.

The <u>CU Board of Regents</u>[5] consists of nine members serving staggered six-year terms, one elected from each of Colorado's eight congressional districts and one from the state at large. The board is charged constitutionally with the general supervision of the university and the exclusive control and direction of all funds of and appropriations to the university, unless otherwise provided by law.

Applications for the <u>2023 Boettcher Webb-Waring Biomedical Research Awards</u>[8] program will be due to the campus grants offices in February, according to the following campus-specific instructions (dates vary by campus): <u>University of Colorado Boulder</u>[9]<u>University of Colorado Colorado Springs</u>[10]<u>University of Colorado Denver | Anschutz Medical Campus</u>[11]

The Boettcher Foundation established the Webb-Waring Biomedical Research Awards program, which will provide up to six grants of \$235,000 each covering up to three years of research activity, to provide independent research opportunities to promising and talented early career investigators. Awardees will carry the title of Boettcher Investigator in acknowledgement of the prestigious award.

Boettcher Webb-Waring Biomedical Research Awards[12] from Boettcher Foundation[13].

Since the first awards granted in July 2010, the Boettcher Foundation has awarded <u>CU's 59 current Boettcher Investigators</u>[14] more than \$13.7 million.

Eligible faculty researchers from all four CU campuses are encouraged to apply. For purposes of this program, an eligible early career investigator (ECI):

Is within four years of appointment to their career-track academic position (i.e., whose career-track appointments began no earlier than Jan. 1, 2019); Has not previously received a major independent research award; Has received a terminal degree or completed their medical residency within the 10 years preceding the application (i.e., on or after Jan. 1, 2013); and Is either a U.S. citizen or permanent resident (at the time of application).
