

[Regents issue unanimous condemnation of June 1 attack, declare support for victims](#)^[1]

COLORADO SPRINGS – At its regular meeting in Colorado Springs on June 4, the University of Colorado Board of Regents unanimously approved a resolution condemning the June 1 attack in Boulder that injured 15 participants in a peaceful vigil supporting Israeli hostages.

“This unprovoked, violent act specifically targeted the Jewish community, reflecting a broader and very troubling escalation of antisemitism in the broader community,” states the resolution. “As an institution of higher learning, where we prize each individual’s freedom to pursue their chosen path, we must speak clearly and with one voice that antisemitic violence should not and will not be tolerated in our communities, in our state and in our nation.”

In 2024, the Board of Regents adopted a resolution condemning antisemitism and all other forms of discrimination. In addition to condemning the June 1 attack, the June 4 resolution cites support for the survivors of the attack and their families, expresses appreciation to law enforcement, other first responders and good Samaritans, and reiterates the board’s condemnation of antisemitism and all other forms of discrimination.

The resolution concludes:

“RESOLVED That the Board of Regents stands in solidarity with all University of Colorado students, staff and faculty, as well as the Jewish community, the Boulder community and all Coloradans, who deserve to learn, work and live in a safe and welcoming environment.”

[Regents approve \\$6.7 billion CU budget for 2025-26](#)^[4]

COLORADO SPRINGS – The CU Board of Regents approved a systemwide budget of \$6.7 billion for the 2025-26 fiscal year. It reflects investments in the university’s people and mission, such as salary and benefit increases, institutional financial aid and deferred maintenance for facilities.

The board voted on the proposed budget, which increased 2.1% over the current fiscal year, during the regents’ June 4-5 meeting in Colorado Springs. Regents previously [approved](#)^[5] tuition, student fees and faculty and staff compensation at the board’s April meeting.

In his [presentation to the board](#)^[6], Chad Marturano, vice president and chief financial officer, said the budget makes conservative assumptions about federal research funding, given the uncertain environment. Historically, CU sees an 8.7% annual increase in federal research awards; the approved budget assumes no increase this year. Marturano said CU remains well-positioned for future research awards in the realms of cyber, quantum and health care, among others.

Marturano also reviewed five-year enrollment projections at the campuses, including expected all-time peaks at CU Boulder and CU Anschutz in the coming year. Improved student retention and growth in resident student enrollment is fueling a 2.7% enrollment increase projected for fall 2025 at CU Boulder. The rise comes despite anticipated drops in international student enrollment, attributed to the uncertain political climate, with forecast drops in undergraduates (down 24.3%) and graduate students (down 14.7%). Other campuses are anticipating smaller drops.

Regents will hear updated fall enrollment figures for all of the campuses during the board’s Sept. 18-19 meeting at CU Anschutz.

As part of the meeting’s consent agenda, the Board of Regents gave approval to several new degrees at CU Denver, UCCS and CU Boulder. In a separate vote, the board also approved new professional master’s degrees in sustainable business and sustainable engineering at CU Boulder. CU I&E Top Finalists (\$1,000 Prize Each)

[Change of Major/Minor Automated Robot Process](#)[17]

A collaboration between the CU Boulder College of Arts and Sciences and the Office of the Registrar, this project automated the major/minor declaration process, eliminating paper forms and manual data entry. The result: improved student communication and increased staff productivity. [Decreasing Clinical Research Startup Time](#)[18]

At the CU Anschutz Medical Campus, the CTRC Study Startup Dashboard has transformed clinical research operations by reducing nursing order finalization time by over 50%. This custom-built tool enhances regulatory compliance, patient safety and interdisciplinary collaboration. [On Time, On Budget: The Key to Award Management Success](#)[19]

This centralized award management system at CU Anschutz automates the research funding lifecycle — from proposal to closeout — ensuring compliance, accuracy and timely reporting. It has eliminated missed deadlines and improved support for researchers. [Research Cores, Rewired: The Case for Automation with Tools You Already Own](#)[20]

By leveraging tools like Qualtrics and Microsoft Dataverse, this CU Anschutz project automated operations in a research core facility, streamlining quotes, invoicing and data tracking. The result: reduced administrative burden and more time for high-impact scientific work.

[New systemwide policy on official university statements approved](#)[22]

The Office of Policy and Efficiency (OPE) has announced a new administrative policy statement from the Office of University Counsel, APS2028-Official University Statements.

State law and existing regent laws and policies establish that the Board of Regents has the sole authority to articulate the university's position on matters of social and political concern. Other members of the university community, such as shared governance bodies, may express their own opinions consistent with applicable laws, policies and resolutions, such as Article 1.E: Freedom of Expression, Regent Policy 1.D: Freedom of Expression, and the Regent Resolution on Statements of Public Concern, but each campus must post a disclaimer in a visible location on the campus website to make clear that such statements are the expression only of the individual or group of individuals authoring them and are not statements on behalf of the university or the campus. Links to the disclaimers may be accessed from each campus's website homepage.

The new APS took effect April 30, 2025.
