Faculty Council wrapped up its meeting schedule for the academic year by celebrating the winners of its [annual awards](#).<sup>[3]</sup>

The governance group honored council members Cindy O'Bryant and Vicky Grove with awards for Distinguished Service, while Anne Fleming received the award for Administrator of the Year. The three received their awards from Faculty Council Chair Alastair Norcross during the May 15 meeting at 1800 Grant St.

O'Bryant, immediate past chair of Faculty Council in 2024-25, is associate dean for academic and faculty affairs and professor in the Department of Clinical Pharmacy at the Skaggs School of Pharmacy and Pharmaceutical Sciences on the CU Anschutz Medical Campus.

Grove, secretary of Faculty Council in 2024-25, is a Teaching Professor of Distinction in the Russian and Nordic programs at CU Boulder's College of Arts and Sciences.

In the Office of Academic Affairs, Fleming is administrator for the Faculty Council Grievance Committee.

The Faculty Council Distinguished Service Award recognizes the service of faculty to CU, and celebrates contributions through participation in faculty governance, particularly through activities in Faculty Council and its committees.

The Faculty Council Administrator of the Year is given in recognition of significant contributions to the university, to Faculty Council and/or to shared and faculty governance.

President Saliman and other CU leaders joined nearly 100 Coloradans in Washington, D.C., June 24-26 for this year's Colorado Capital Conference, a longstanding tradition unique to the Centennial State.

The conference – cohosted by Sens. Michael Bennet and John Hickenlooper, CU and Colorado Mesa University – gives Colorado residents the opportunity to interact with legislators and leaders in our nation's capital and gain key insights into how our federal government works. Participants are selected through a competitive application process.<sup>[5]</sup>

“By providing insight into our democratic process and making space to engage around our shared values as Coloradans and Americans, the Colorado Capital Conference goes a long way in bringing us together,” said Saliman, who was joined at this year's conference by CU Regents Nolbert Chavez, Elliott Hood, Frank McNulty, Ken Montero, Ray Scott and Mark VanDriel, in addition to CU Denver Chancellor Ken Christensen, CU Anschutz Chancellor Don Elliman, School of Medicine Dean John Sampson and UCCS Chancellor Jennifer Sobanet. Students from each CU campus also attended.

The 2025 conference included panel discussions with experts and policy makers on topics ranging from AI in health care to navigating global challenges, a keynote lunch focused on bipartisan insights from Colorado chiefs of staff, a presentation by House Minority Leader Hakeem Jeffries, a tour of the U.S. Capitol led by Rep. Joe Neguse, and numerous opportunities to interact with other members of Colorado's congressional delegation.

[Díaz Bonacquisti joins Prosperity Denver Fund board of directors](#)[23]

Judi Díaz Bonacquisti, vice president for collaboration at CU system administration, is a new appointment to the board of directors of Prosperity Denver Fund, a nonprofit that champions postsecondary education access for Denver students.

[Prosperity Denver Fund](#)[24] provides financial reimbursements to eligible Denver nonprofits, increasing access to college, apprenticeships and other credential programs for Denver students. Since 2018, the fund has supported programs working with more than 37,000 students and reimbursed \$48 million to nonprofits in Denver.

“Our mission at Prosperity Denver Fund is to ensure that every student in Denver can access the resources they need to get to and succeed in postsecondary education,” said Rebecca Arno, CEO of Prosperity Denver Fund. “Dr. Díaz Bonacquisti’s extensive experience in higher education and commitment to equity will be invaluable to our work.”

[Díaz Bonacquisti](#)[25], whose nomination was advanced by Denver Mayor Mike Johnston and approved by City Council, will serve on the board through April 2028.

For more than 25 years, Díaz Bonacquisti has developed programs and policies to expand college access and advance students toward college-degree completion. She has served as senior student affairs officer, senior enrollment officer and senior diversity officer. She has a track record for advancing equity in education, particularly for students of color, first-generation students, undocumented students and students from low-income backgrounds.

Díaz Bonacquisti has served at public and private colleges and universities with a range of academic offerings, admissions selectivity and student populations. She was appointed by then-Gov. Hickenlooper to serve on the Educational Leadership Council and was nominated and jointly appointed by the State Board of Education and the Colorado Commission on Higher Education to serve on the Educational Success Task Force.

A native of Pueblo, Díaz Bonacquisti earned a doctorate in education in leadership for educational equity from CU Denver, a master's in business administration from UCCS and a bachelor of science in civil engineering from Colorado State University. She earned certificates from Harvard's Institute for Management and Leadership in Education and Leadership in Enrollment Management from the University of Southern California.

Denver voters in 2018 passed a ballot initiative known as Prosperity Denver, calling for a 0.08% sales tax (less than one cent on \$10) dedicated to support Denver students as they pursue college and career opportunities after high school. Prosperity Denver Fund, a 501(c)3 nonprofit, manages and distributes this funding, contributing millions each year to eligible organizations.
